The company is disclosing information explaining the difference in after-tax profit that decreased compared to the same period last year in the Q4 2025 financial report as follows:

The company's after-tax profit in Q4 2025 decreased compared to the same period in 2024 due to the following main reasons:

In Q4 2025, the stock market experienced significant volatility, trading volume decreased, and stock prices also fell compared to the same period last year, leading to a sharp decrease in revenue from proprietary trading activities.

Although the company managed to reduce some financial and administrative expenses during the period, the sharp decrease in revenue from these activities resulted in a decrease in profit compared to the same period last year. These are the main reasons for the decrease in business results during the period compared to the same period last year.
